A. IDENTITY OF THE DATA SUBJECT

B. PROCESSED PERSONAL DATA AND PURPOSE OF PROCESSING

Your personal and private data listed below are processed and stored in accordance with the procedures and principles stipulated in the relevant law and other laws.

Providing information to authorized persons, institutions and organizations in cases such as your personal data such as **identity data, communication data, financial data , in the process of supplying goods and services, carrying out activities in accordance with the legislation, carrying out financial and accounting works related to the purchase of goods and services, filing tax returns**, It may be processed for processing purposes such as carrying out the supply chain management processes of the procurement processes we make, carrying out the storage and archiving activities of the said contracts and other data, executing the contract processes to be established, communicating with the supplier and its employees through tools such as e-mail and telephone during the contract processes. During your physical visits to the administrative building of BAŞARI TUTKUM BİLİŞİM PROJECT AND LOGISTICS ANONİM ŞİRKETİ , your physical space security data, such as camera recording data, are carried out in order to carry out emergency management processes, to ensure physical space security, to carry out risk management processes, to ensure the security of movable goods and resources, to create and follow up visitor records. It can be processed for processing purposes such as In case of legal disputes that may arise between us, your legal transaction data may be processed for the purpose of conducting legal operations.

C. BY WHAT METHODS AND LEGAL REASONS PERSONAL DATA IS COLLECTED

Your personal data, in accordance with the data processing conditions specified in the Law, arising from the contracts made with the suppliers, during the establishment of the contract; In the supply of goods and services, primarily through the contracts made physically or electronically, for the purpose of carrying out communication activities only, generally over electronic / mail / telephone environments, face-to-face in voice, over waybills, software used within the company, physical documents and forms, camera systems It is collected through administrative and judicial correspondence in line with the following legal reasons;

1. Data processing is mandatory for the legitimate interests of our Companies, provided that it does not harm the fundamental rights and freedoms of the supplier employee.
2. It is necessary to process the personal data of the parties to the contracts, provided that it is directly related to the establishment or performance of the contracts to which the supplier employee is a party.
3. It is clearly stipulated in the law and/or it is mandatory for our Data Controller Company to fulfill its legal obligation.
4. It is compulsory for the establishment or use of the rights arising from the legal relationship in question.

D. PERSONAL DATA IS TRANSFERRED TO INC . AND FOR WHAT PURPOSES

Your personal data; Within the framework of the provisions of the transfer of personal data specified in Articles 8 and 9 of the KVKK; In case of a legal dispute, it can be transferred to legally authorized public institutions and organizations, judicial and administrative authorities, our contracted supplier lawyers, other suppliers and business partners if necessary for the execution of business activities, and our supplier financial advisors in order to carry out financial and accounting works.

E. YOUR RIGHTS AS THE RELATED PERSON AS THE OWNER OF PERSONAL DATA

As personal data owners;

1. Learning whether your personal data is processed or not,
2. If your personal data has been processed, requesting information about it,
3. To learn the purpose of processing your personal data and whether they are used in accordance with the purpose,
4. Knowing the third parties to whom your personal data is transferred, in the country or abroad,

5. Requesting correction of your personal data in case of incomplete or incorrect processing and requesting notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
6. Requesting the deletion or destruction of your personal data in the event that the reasons requiring processing are eliminated, although it has been processed in accordance with the provisions of the KVK Law and other relevant laws, and requesting the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
7. Objecting to the emergence of a result against you by analyzing the processed data exclusively through automated systems,
8. You have the right to demand the compensation of the damage in case of loss due to unlawful processing of personal data.
